General Information 2019 – 2020

Artist in Residence programs provide hands-on learning opportunities for students through three, five and ten-day artist-led projects. Residencies offer opportunities for collaboration, building innovative and creative projects, where students have multiple opportunities to work with the artist, allowing for an in-depth and enriching artistic experience.

- 1. MASC offers two types of artistic residencies:
 - a. Art for Art's Sake uses an art project to make links to the arts curriculum, offering creative experiences to students to inspire, develop critical thinking and other skills.
 - b. Arts Integration uses an art project to meet curricular goals in non-art subject areas, using art to cross the boundaries of core subjects and artistic concepts. It combines art with another subject to encourage the development of a new perspective on the material, allowing for a creative means of expressing what is being learned.
- 2. A residency is defined as an artist working for three or more full days with a single class or several classes. Half day programs are not eligible.
- 3. When allocating funding, MASC will give priority to projects where students have the opportunity to participate in multiple workshops with the artists.
- 4. Subsidies are offered for residencies involving MASC artists only.
- 5. MASC does not fully fund residencies. A balance will be owed by the school.

- 6. Funding decisions will be made depending on the quality of the project, the number of applications received and funding available.
- An evaluation report and thank you letter(s) to the subsidy funder must be sent to
 MASC within 2 weeks of the project's completion, including one to three photographs
 with permission for use by MASC.
- All residencies must be completed by May 10, 2019, with reports and letters received by May 24, 2019.
- Travel costs: Schools over 25 km. from Ottawa centre will be charged transportation costs. Please contact MASC for travel costs specific to your project.

Subsidies Available 2019 - 2020

Please check your school's eligibility based on the criteria below:

City of Ottawa Rural Initiatives Subsidy Available to schools or community groups situated in rural districts of the City of Ottawa (Goulbourn, Rideau, Osgoode, West Carleton, Cumberland).

Subsidies will be awarded considering the following criteria:

- The project must be clearly articulated, artist-led and provide 'hands-on' creative
 experiences. Participants will have an opportunity to work with an artist multiple times
 over several days to allow a more in-depth and enriching artistic experience.
- Projects may be designed with one artist or they may be cross-disciplinary, with more artists involved.

Important Notes

 For a residency of up to five days, MASC typically offers subsidies of \$165 per day (for a project led by one artist) and \$190 per day (for a project with multiple artists.)

Conditions for subsidy and signatures

If your project proposal is selected, you will need to agree to all of the following conditions:

- Sign an agreement form confirming your acceptance of the subsidy.
- Provide media consent for use of photographs of students and projects. These will be used for MASC's promotional purpose only.
- Confirm the dates and project schedule within 3 weeks of receiving funding approval.
- Coordinate a meeting (minimum two weeks prior to project commencement) with the artists to discuss project content, goals and specific needs of the participants.
- Inform MASC if there is a change in project description, dates, coordinator or artists selected.
- Pay the invoice one month prior to the project's commencement.
- Complete the project by May 11th, 2020.
- Send a written evaluation and supporting documentation such as student's work,
 photos etc. within 2 weeks of project completion.

- Notify MASC of any media attention the project receives.
- Acknowledge the funder and MASC in all media, communications and promotional materials pertaining to the project.

Notification of funding for applications submitted by the deadline will be sent by November 12th, 2019.

Frequently Asked Questions and Helpful Hints

1. How much of a subsidy can I expect to receive?

MASC typically allots between \$165 and \$190 per day, depending on project's costs, the number of artists involved, and the number of applications received.

2. Does MASC send me a cheque for the subsidy?

No, MASC will not send you a cheque. The subsidy amount is deducted from the overall cost of the project. MASC will send you an invoice with the balance owing, once the dates and schedules have been confirmed with the artist. MASC does not fully fund the project; a balance will be owed by the school.

3. What is the payment procedure?

The invoice you receive is payable to MASC one month prior to the project's completion.

The school pays MASC. MASC pays the artist directly.

4. If I submit my application on time, does this guarantee I receive a subsidy?

No, MASC subsidies are subject to the availability of funds we receive from our donors, the quality and number of applicants. This varies from year to year.

5. How will I know if my application has been successful?

We will notify you by email. The agreement will then require signatures from both the project coordinator and the school principal. This agreement must be signed and returned to MASC in order to secure your funding. The agreement confirms that you accept the funding, intend on completing the project and commit to paying the balance owing.

6. Do I have to contact the artists before submitting my application?

No, you do not need to contact the artist prior to applying for a subsidy. Once the funding is approved. MASC will contact the artist on your behalf to outline the project, negotiate dates and schedules. If you wish to discuss the project with an artist before submitting the application, the MASC residency coordinator can put you in contact with the artist.

7. May I contact the artist before submitting my application?

If you wish to discuss the project with an artist before submitting the application, the MASC Residency Coordinator can put you in contact with the artist.

8. Is there anyone else who can help me plan my project?

MASC's residency coordinator is also available to you for advice in planning your project for the application.

9. What happens if I need to cancel or make changes to the project plan?

MASC's cancellation policy is indicated on your confirmation and on our website. Please read it carefully. You must notify the artist and notify MASC if there are any changes to the schedule or your project's content.

10. May I apply for funding a single performance or one day of workshops?

No, residency funding is for multi-day, full day projects. Eligible schools may apply for short-term funding by Alejandro Salgado at alejandrosalgado@masconline.ca
